One cut-thru in the median east of Whispering Hills Dr. on Walnut St. and another to the west, together costing \$75K, are in the planning and execution stage. This activity has been requested for years to reduce U-turn traffic and accidents at the Walnut intersection and at the Whispering Hills / Branwood intersection due to Briarwyck Apt. residents' difficulty in entering and exiting the complex.

## **Deermont Speed Cushions**

Report from the Dallas Department of Transportation

Staff conducted two traffic studies on Deermont, one in June and one in September. According to the data collected, the qualifications for speed cushions were not met.

The findings from the 24hrs in-house traffic study conducted on 06/29/2023 are as follows:

- 85th Percentile Speed (speed at which 85% of drivers travel) - 32 MPH  $\,$ 

- Average Speed - 27 MPH

The findings from the 24hrs in-house traffic study conducted on 09/14/2023 are as follows:

- 85th Percentile Speed (speed at which 85% of drivers travel) - 31 MPH  $\,$ 

- Average Speed - 26 MPH

- Total Average Daily Traffic (ADT) - 380 Vehicles

Common engineering practices recommends the installation of speed cushions on local residential roads where the 85th Percentile speed equals/exceeds 35 MPH and has an ADT of 500-8,000 vehicles. Due to these characteristics, the installation of speed cushions on Deermont Trl from Whispering Hills Dr to end of Dallas city limits is not recommended.

This information will be added to SR 23-00294383 and closed out.

## Neighborhood Association (NA) vs Homeowners Assoc. (HOA)

WHNA is a NA

A Neighborhood Association (NA) is a volunteer organization of residents who work together to improve and maintain the quality of life in its neighborhood. Associations can form out of concern over a particular issue or as a means of enhancing a "sense of community."

Features of a Neighborhood Association:

□ Membership is voluntary and open to all residents, not just property owners, in the neighborhood.

 $\hfill\square$  Participation is optional and boundaries are established by the association.

□ Membership dues are voluntary

□ There is no legal authority to enact or enforce maintenance or design requirements beyond those established by City ordinances.

 $\Box$  To ensure a visibly democratic process, the organization establishes formal or informal bylaws to provide for at least one general membership meeting per year and to require an annual election of officers.

A Homeowners Association (HOA), unlike a neighborhood association, is a formal legal entity created to maintain common areas and enforce private deed restrictions. Most condominium, town house developments and newer single-family subdivisions nowadays have home owner associations created when the development is built.

Features of a Homeowners Association:

□ Membership is mandatory for all property owners within the boundaries of the development.

□ Members are charged mandatory dues.

□ Homeowners associations have the legal authority to enact and enforce maintenance and design standards in addition to those established by city ordinance.

□ Homeowners associations are corporations, with formal bylaws, which have a governing board that may be elected annually



## Basics



- Permit from Code is required. Libraries are no longer issuing them.
- There is a limit of two (2) garage sales at a premise during any twelve (12) month period (**NOT by calendar year**) and each sale may not exceed more than three (3) consecutive calendar days in length.
- Signs must be placed on private property; Signs placed on medians, public property or utility poles are illegal
- Signs must be removed within 24 hours of sale.
- 1st Garage Sale -No Fee
- 2nd Garage Sale -\$25.00 (No Cash)

## White Rock Lake on the List of Most Haunted Places in North Texas

Lady of the Lake, a well-known legend, is about a ghost that haunts the White Rock Lake Park.

The story first came out in 1943 when Anne Clark published "The Ghost of White Rock." In the story, a young couple was parked on the shore of White Rock Lake. They switched their headlights on and saw a woman dressed in a sheer white, wet dress coming towards them. She stated her boat was overturned and that she needed a ride home. She crawled into the couple's car and gave them an address in Oak Cliff. They drove to the address and met a man who told them his daughter drowned while sailing on the lake three weeks before. They were told they were the third couple who had came to his house with the same story, according to WhiteRockLake.org.

In 1953 a similar but much more detailed account of the Lady of the Lake legend was included in Dallas author Frank X. Tolbert's book, Neiman-Marcus, Texas: The Story of the Proud Dallas Store. In this account, a beautiful blonde girl appears on the road near White Rock Lake. Mr. and Mrs. Guy Malloy, directors of display for Neiman-Marcus, spot her standing as if she had just walked up from the beach. Upon seeing the girl standing in the beams of their headlights Mrs. Malloy said:

"Stop, Guy. That girl seems in trouble. She must have fallen in the lake. Her dress is wet. Yet you can tell that it is a very fine dress. She certainly got it at the Store."

Meaning, of course, Neiman-Marcus. The friendly girl asked them to take her to an address on Gaston Avenue in nearby Lakewood. She didn't offer an explanation for her state, and the Malloys were too polite to ask. Her long hair began to dry in the night breeze. Mrs. Malloy was now sure the girl's dress was from Neiman-Marcus. The girl got in the back seat of the two-door sedan. When the car started, Mrs. Malloy turned to discover the girl had vanished. The only trace of her was the damp spot on the back seat. Puzzled, the Malloys went to the address she provided them. A middle-aged man met them at the door. He informed them that his blonde daughter, who wore nothing but Neiman-Marcus clothes, drowned two years before when she fell off a pier at White Rock Lake.

No Garbage or Yard Debris

Only These Items

(Do Not Put Items in Plastic Trash Bags)

<u>Glass Bottles and Jars</u>--NO window glass, light bulbs, fluorescent tubes, ceramics, mirrors or Pyrex

**<u>Plastics</u>**--containers (rinsed) labelled #1-5 & 7 (found at the base of the container in the recycling emblem) **NO** plastic grocery bags (take those to the store), plastic wrap, plastic utensils, chemical containers or Styrofoam

<u>Metals</u>--steel, tin and aluminum (cans) NO foil or foil containers used for baking; no electronics or toys

**Paper Products and Cardboard**--newspapers, books (both paper and hardback) magazines, catalogs, envelopes, food and detergent boxes, paper egg cartons, 1-pack drink cartons, cereal boxes, folded corrugated and cardboard boxes; **NO** food contaminated boxes or plastic or foil-lined boxes or shredded paper
